

FUNDING APPLICATION AND GUIDELINES 2011

NATO CHARITY BAZAAR

The NATO Charity Bazaar ASBL has been holding its yearly charity event since 1968. Though the Organization raises funds throughout the year, the Bazaar is the social event of the year within NATO's international community. Participants in the annual Bazaar are the Members of the Alliance as well as the Partner-for-Peace nations. In 2010, 34 nations were represented.

CHARITY SELECTION PROCESS

Two categories of projects are funded:

- Belgian and International Charities: (50%/50%)
- Emergency requests: These donations are for exceptional or extremely urgent cases. The requested donation should not exceed the amount of 2.000 €. The donations are made throughout the year.

Factors taken into account when selecting charities for donation:

- The request should be for a specific project.
- The charity should be a non-profit organization officially registered (ASBL or VZW if located in Belgium) for at least one year.
- If benefiting organizations receive funds or authorization for funding for a project from the proceeds of a specific Bazaar, two complete calendar years must pass from the date of that Bazaar, before the same organization may reapply to the NCB (for example, an organization that has benefited from funds raised at the 2010 Bazaar can next apply in 2013).
- Application forms must be complete. All questions and requests for explanation should be addressed. If the question is not applicable to your organization, then write "Not Applicable."
- To be considered a Belgian charity, the organization must exist in Belgium.
- We are most interested in funding projects that are:
 - Small specific projects preferably ones that can be completed with the set amount within a year.
 - Projects that cover the widest spectrum of the community.
 - Projects which, when completed should have a long term impact and be of benefit to as many people as possible.
 - Projects benefiting NATO countries, NATO PfP countries, and countries where NATO is currently engaged for example in Afghanistan – but without excluding projects from other geographic locations.
- Staff salaries and administration costs as a general rule are not supported.
- The maximum amount donated is 10.000 euros.

The NATO Charity Bazaar members vote on the final list of charities to be funded.

APPLICATION PROCESS

All proposals are due by <u>1 MAY</u> of each year. If funding is awarded, the funds will be transferred in December 2011 with a Donation Ceremony in January 2012. Receipts for goods purchased with funds are required.

- All Belgian charities will receive a personal visit from a representative of the organization.
- All correspondence should be in English and/or French.


ENGLISH VERSION

Through this project we are looking to purchase an advanced medical equipment which will help the early detection of diseases with a significant impact on traffic safety. The purchased equipment is called coagulation analyzer and together with other laboratory equipment forms a complete circuit necessary for detecting diseases with a significant impact on traffic safety. Around 400 free laboratory analyses will be annually made in the field of traffic safety.

FRENCH VERSION

I. Organization Information

1. Brief Summary of Organization's history and mission.

The Medicine and Traffic Safety Association was founded in January 2010 at the initiative of specialists from the field of medical, economic and legal science who are interested in medical activity. The association is working in the sanitation sector and its purpose is *The growth and development of traffic safety in Romania*. Romania, regarding percentage, has come to have the highest number of deaths caused by road traffic-related events and it is estimated that in addition to the approximately 3,000 deaths caused by road traffic per year, annually at least 10,000 persons remain with significant disabilities after road accidents

In order to achieve the objectives we are collaborating with a series of public institutions, sanitary units and other organizations, agencies and NGOs operating locally: such as Agape Foundation from Salard, Bihor County; Maltese Relief Service in Romania Bihor Affiliate and across the borders AID Dorkas Hungary Association from Debrecen.

2. Description of current programs, activities, and strengths/accomplishments (highlighting the past year), including what makes your organization unique.

During 2010 the association has carried out a series of activities. The most important are the following:

- Conference on <u>Traffic and Safety Medicine</u> held between 14-15.05.2010 at Oradea City Hall. During this conference the issue of sleep medicine and its importance in road safety was discussed for the first time. Later, this concept became a medical specialty through the Order of the Minister of Health of Romania.
- Conference on <u>News regarding health care reform in Bihor hospitals</u> organized in collaboration with Oradea City Hall. This conference was attended by all hospitals' board from Bihor County. It was discussed for the first time the classification of Romanian hospitals on categories of competences.
- Project "Empowering young people about traffic safety" financed by the Oradea City Hall and by The Medical Association and Traffic Safety. The aim of this project is to reduce the number of road accidents among young people and addresses a total of 500 youth within the age of 10-18. The project focuses on the movement of pedestrians, cyclists, mopeds, motor vehicles, traffic rules, driving behaviour and last but not least on a minimum knowledge of first aid.
- Donations of medical equipment, medical supplies, medical furniture, IT equipment to: Railway

Hospital Oradea, Neurology and Psychiatry Clinical Hospital Oradea, Department of Social and Child Protection Bihor, Maltese Relief Service in Romania, Dr. Gheorghe Pop Marghita Municipal Hospital.

II. Purpose of Funding Request

The recorded number of deaths caused annually by traffic accidents in Romania equals with the disappearance of a medium size rural town from the country's map.

The Medical equipment purchased through the project will be used to make free medical analyses in order to detect earlier the diseases which affect road safety and thus to maintain a state of health and skills in the field of work with an impact on road safety.

There are many diseases that can affect the ability to drive: cardiovascular disease, ophthalmic diseases, diabetes, mental illness, respiratory disease and so on. Preventive medical work among people with responsibilities in road safety is a major element in the influence of morbidity and mortality caused by road traffic accidents and prevention is achieved through prevention laboratory investigations and medical examinations.

The Medicine and Traffic Safety Association together with The Railway Hospital Oradea, regularly organize activities meant to prevent road accidents. The activity of making preventive medical analyses is part of the activities carried out regularly.

Last year over 380 persons with active function in traffic road received free medical examinations. The medical equipment which is currently being used to detect kidney disturbances or metabolic or systemic diseases of other organs (liver, pancreas) is exceeded in terms of ethnic. Due to the fact that it is 8 years old and it does not work properly anymore we intend to replace it with a modern one that provides accurate results in a short time.
