

General Assembly E-mail Voting Minutes

27 March, 2020

Due to the general lockdown regulations imposed by NATO and the Belgian government concerning the COVID-19 pandemic situation, the General Assembly of the NATO Charity Bazaar ASBL carried out a process of voting by e-mail between 19 and 27 March 2020.

The following decisions were made by the Members of the Association, based on the e-mail votes sent until the deadline of the voting:

- (1) The General Assembly approved the updated Statutes 2020 with 36 votes
- (2) The General Assembly approved Internal Regulations with 36 votes
- (3) The General Assembly approved the members of the Board 2020 with 36 votes
- (4) The General Assembly approved the updated Statutes 2020 with 35 votes

According to the Statutes of the Association, the quorum of the votes in each decision point was reached.
