- Creating a general email account will facilitate communications during all periods of transition that will occur within your Representative Team for the NATO Charity Bazaar
- It is advised to check your Spam folders emails from the NCB often disappear in the spam folders when recipients use webmail addresses
- We have had "Member Stamps" with logo and year on them issued for the member nations to use as an alternative to our official NCB logo which is for Board use only.
 - The Member stamps come in a French, as well as in an English version, and the Board encourages Nations to use this in their official, external correspondence (Sponsor letters, thank you notes, etc.). The stamp will be re-issued in 2021. Members provided positive feedback on this new initiative.
- NCB has been granted permission to issue Newsletters NATO-wide via the channels of
 communication in existence at NATO HQ. This means we will have yet another media by
 which we can reach our NATO community to announce the issue of catalogues, tombola sales,
 mask sales and other campaigns. We plan to issue frequent Newsletters NATO-wide from now
 until the end of November.
 - Fund-raising best-practices- Vice-president, Hanne Jørgensen:
 - At the last GAM I believe everyone present realized the immense value of having NRs & ANRs from Member Nations speak about their ideas, challenges, inspiration and thoughts
 - We have moved on now activities have evolved catalogues are appearing and things are really happening
 - Therefore; we have asked NRs from different nations to share and to talk about their individual nations' ideas, challenges, hopes and ambitions again at this GAM
 - Lucky for us 7 Nations were willing to share this time: North Macedonia, Finland, Kazakhstan, Lithuania, Spain, Estonia & Bosnia & Herzegovina
 - Please participate in the debate and remember when asking questions or commenting, put your country name in the Chat, and we will get back to you as soon as we can to hear your inputs

Ivica Doneski from North Macedonia:

- Big challenges with the move into the new NATO HQ as the new member no. 30 of NATO and new offices still under construction and big challenges with the overall situation caused by the pandemic
- Sponsor Donations instead of purchasing & selling products from North Macedonia as they have done in the past. Money has been collected from donors instead and will be transferred to NCB in due time
- Are also selling tombola tickets
- We hope next year's bazaar will be back to normal in the Agora!!

Chat message:

Question about where to find the catalogues? (Netherlands)

They can be found on the NCB Website (with member log-in), NCB Facebook Site as well as in the newsletters that are going out NATO-wide and are accessible for all

Marjo Toivo from Finland:

- In order to encourage the sale of tombola tickets, we are giving out a small chocolate gift for those who buy an entire booklet of 10 tickets. It is harder to reach people, as they are primarily working from home these days. Half of their tombola tickets are sold so far
- October 4th was "International Cinnamon Bun Day", and we had a sale at the delegation which went well despite the near empty offices
- We are going to promote a catalogue full of traditional Finnish products (Reindeer hides, Cloudberry Liquor, Finnish Chocolate, little designer items, Jewellery, etc.) It has been easier to collaborate with smaller companies than the larger ones
- Have attached printed ingredients lists to perishable goods in Dutch to ensure they comply with Belgian legislation
- Challenges but also possibilities this year!

Saule Kazybayeva from Kazakhstan:

- Thank you to the Board for all their support
- Catalogue of our products is on the way it has been a lot of work, and we have many items in the catalogue many of the items are items which normally sell well
- Delivery from Kazakhstan was very difficult but thanks to the help of friends, we managed
- Distribution/delivery challenges, as our embassy is in Uccle however; we have now found an address (residential) closer to NATO HQ
- Can we discreetly use the lockers at NATO to distribute items as well?
- Which method of payment is more convenient? We would like to hear from others about their experiences with payment.
- I wish all the Nations all the best with their efforts this year.

Chat message:

Response from the USA/Marjorie: The USA use payments in the form of bank transfers only. It is quick and works well.

Response to question about distribution from Szabina: We ask that you prepare your catalogues and first off send them to Alicia, our coordinator, partly so she can check content, and partly so she can approve your method of distribution. Once approved by Alicia, it may be distributed to your own NATO community. We will ensure it is published in our channels as well.

Zaneta Baltreniene from Lithuania:

- Catalogue is on the way with MANY items from Lithuania.

- Lucky to have found 7 sponsors for Tombola prizes
- Small change for BIG change Jars have been placed in the delegation as well as in the EU delegation
- Preparation has been substantial for the catalogue I was doing it on my own
- It has been a challenge to sort out the distribution issues for the catalogue goods. (Szabina repeats, that we must all adhere to the rules of NATO HQ and so we need to find alternative places to pick up items maybe do what some nations are doing have specific pick up dates at the end of November and please maintain locations outside of NATO)
- Our tombola ticket sale has been really successful this year 350 tickets in a very short time
- I hope the Bazaar will be successful

Lucia Zaragoza from Spain:

- Have had a great and supportive Spanish Team this year
- Local Spanish donors of tombola gifts and catalogue items
- Main problem is storage and delivery of items but it has been solved by a team member whose garage we may use for this
- Lucia presented Spanish examples of initiatives on a separate slide (slide 15): Padel Tournament where proceeds go to NCB, homemade Christmas decorations and local delicacies in the up-and coming Spanish Catalogue

Hedi Schvede from Estonia:

- This year Estonia have been unable to market their traditional, gorgeous clothing (sweaters, Jackets, ponchos, hats, etc.) as these must be tried on for size, something which is not possible this year
- Instead they are selling other items this year
- Bake Sales have been successful in the delegation thanks to the help of spouses as well
- Tombola sales are going well

Siniša Tintor from Bosnia & Herzegovina:

- Thank you to the Board for support and for keeping the Bazaar "alive"
- Congratulations to all the member nations catalogues look great thank you
- We are a small nation less than ten people at the delegation so it is challenging to organize anything extra
- Almost impossible to get any items from home due to the pandemic
- Donations are collected as best we can and will be donated to the NCB
- We all hope to return to a "normal" bazaar next year, but I do think we should mentally prepare ourselves for a very different year again next year
- I still think we should try to organize selling preordered food/cookies/baked goods at a stand in Aramark (Canteen) I would like to suggest this even for next year
- Lessons learned process should start in December 2020

Girts Aleksis from Latvia:

- Tombola sales have been better this year 50% up compared to last year maybe people are feeling slightly guilty this year?
- We had no problems obtaining sponsored gifts this year
- Optimistically I judge we should only lose 1/4 of funds compared to a normal year
