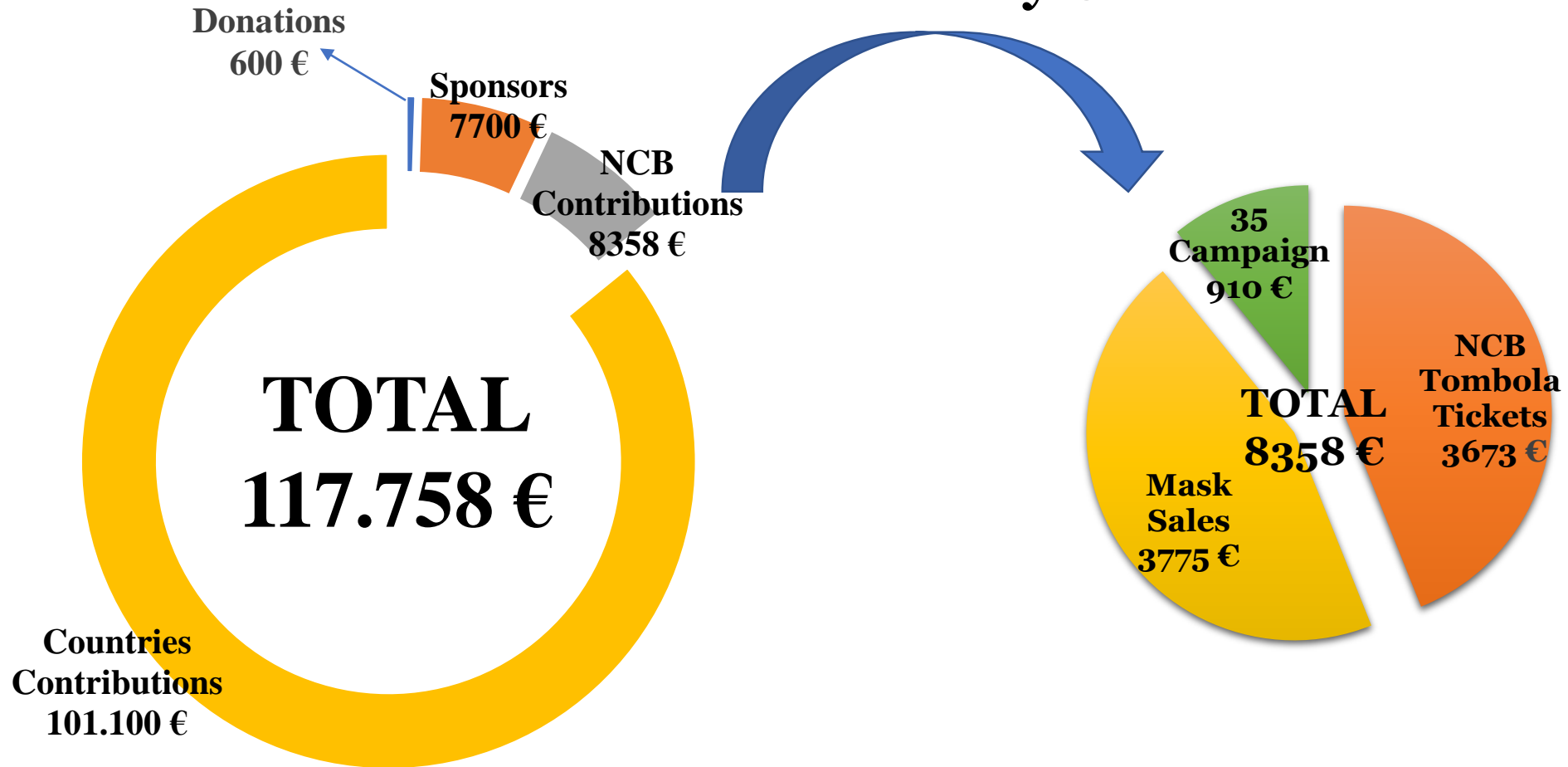

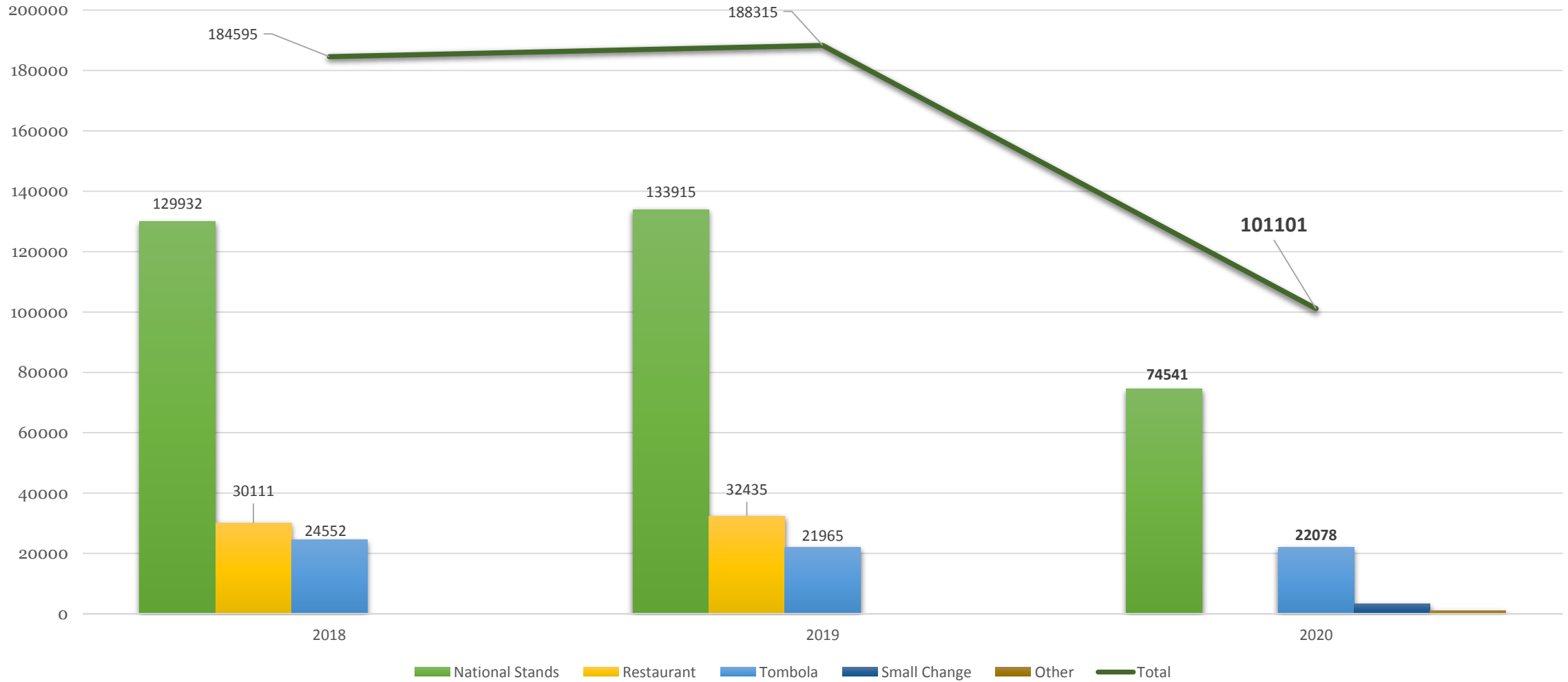

## Where Did the Money Come From?

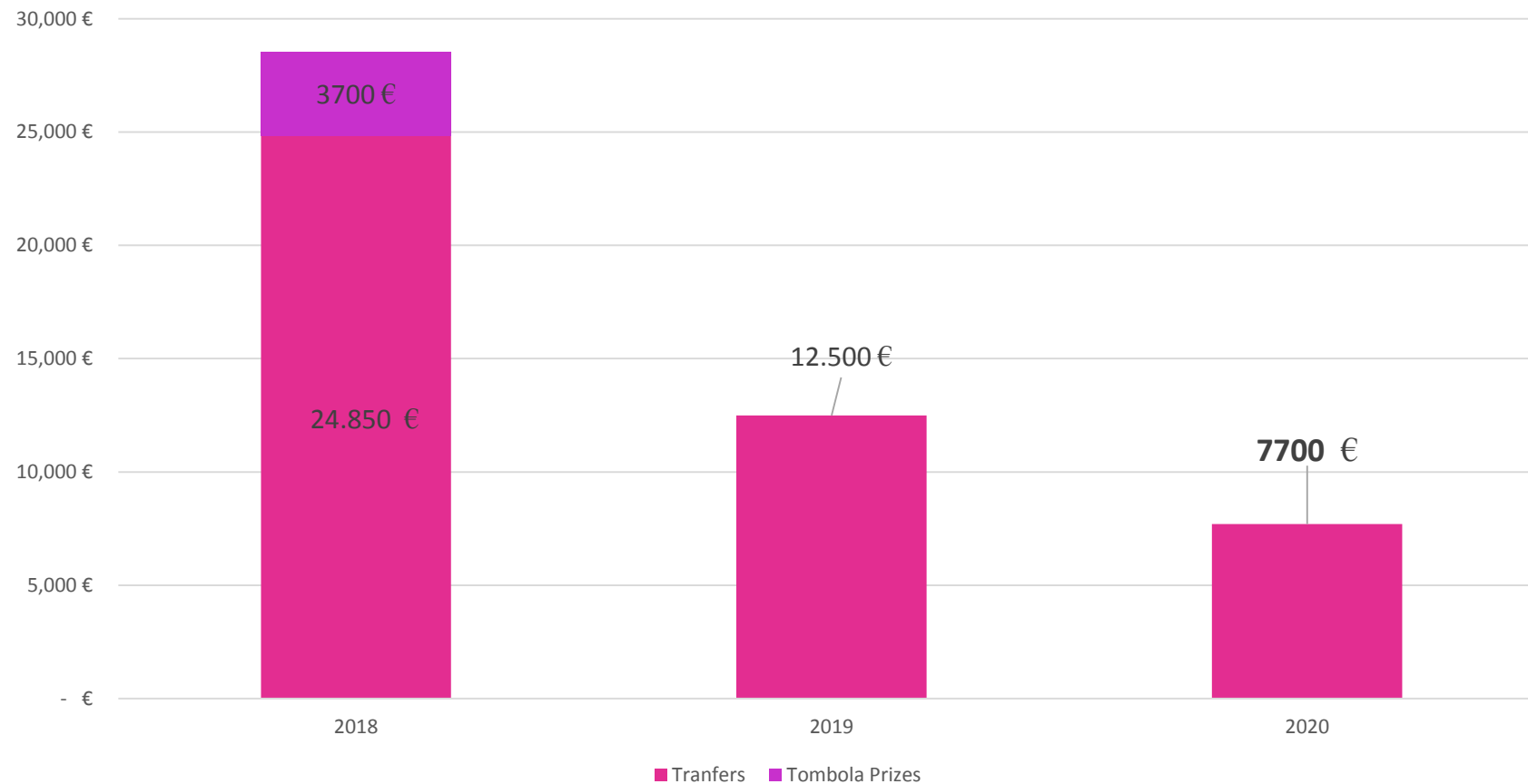

- September 2021: National Representatives rank the approved Charities in order of priority
- December 2021: NCB Board disburses monies to approved Charities

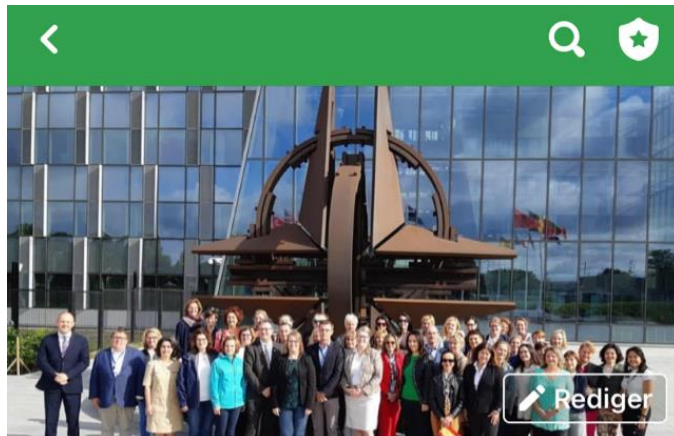

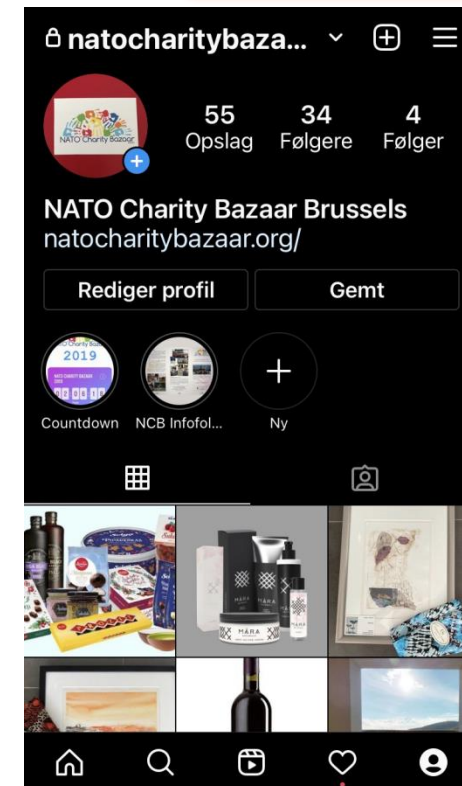
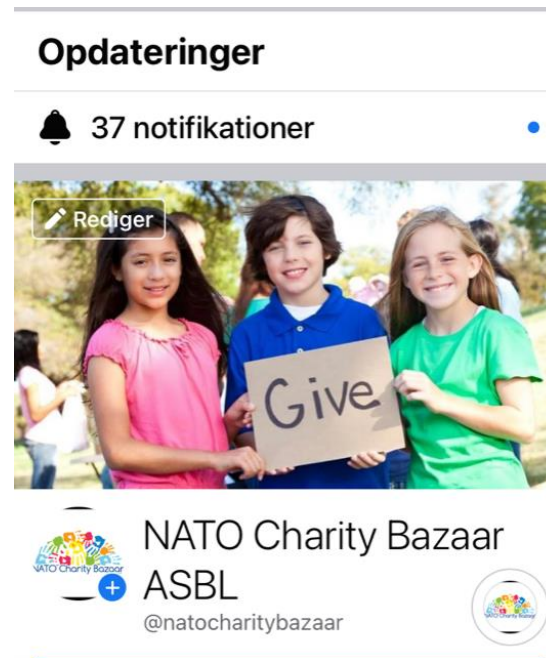
