Charity Team Leader: Funding applications 2022

Update on the 2022 NCB charity application process, funding applications 2022

All information on the Selection Process and the Application Form as well Guidelines 2022 (in English) is available at <u>https://www.natocharitybazaar.org</u>

Deadline for receipt of completed applications was 1st May 2022 at 12h00(noon) Central European Time (CET).

Charity Timeline

April 1 - May 1 at 12.00 CET - window for accepting applications for Charity Projects. Each application has been forwarded to the appropriate coordinator.

May 2022 – June 2022: Review of all applications for eligibility, ensuring all requirements are met. All the applications are reviewed by the NCB Board. The Charity Team can accept up to 35 applications only, with only 2/country except for Belgium, per our Internal Regulations and Statutes. This ensures we can assist as many projects as possible from as many countries as possible.

July: All Charities are notified, via email, with either Non-Funding or Possible Funding letters after the reviews and process of eligibility and selection criteria is done.

August: Charity Briefing Books will be distributed to all National Representatives in preparation for the September GAM.

September: We anticipate voting via Survey Monkey online (like we did last year). This virtual way of voting ensures correct tabulations of all the votes and ensures all NR's can vote, even if they are not in Brussels at the time.

December: The Board meets after the Bazaar to distribute the funds. 35% (thirty-five) of the raised amounts will be distributed to the Belgian Charities while the other 65% (sixty-five) of the amount is distributed to the International Charities.

All charities are notified via email of funding and the received amount.

January 2023: Hybrid Donation Ceremony event (in person at HQ and Zoom)

Update on the 2022 Belgian and International Charities

4 projects from Belgian Charities and 24 International projects from 13 countries received

The charity vote will take place during the first GAM of September

Bazaar Coordinator: The NATO Charity Bazaar 2022 event

<u>Time:</u> From 18th to 20th November (3rd weekend of November) – pending, tbc

Location: NATO Staff Center

<u>How?</u> The set-up of National stands will be at HighFive Omnisport Hall area & Restaurant stands will be organised at the restaurant area of the Staff Centre.

This year we need again to adapt to the new challenges which affect our Bazaar activities as well

At the general question "Why the Bazaar event does not take place at the Agora public area?" there are multiple reasons: security reasons, uncertainty of a firm commitment to a specific date as well the possibility of an unexpected cancellation/postponement

We must adapt to some limitations in terms of Product Stands

Maximum number of tables will be imposed (the number depends on how many nations will participate)

As soon as all the Questionnaires are collected, an initial sketch of the hall could be drawn up

The use of electrical devices – slightly limited (a decision in this regard is still awaited)

The nations will bring their products in slots (a schedule will be set up),

Diana shows photos of the locations at Staff Center

More specific details will be provided once we are aware of the level of participation

Q&A:

Tanya: asks about the restaurant stands set up.

<u>Diana:</u> responds that for restaurant sales/foods there will be available the whole restaurant Staff centre area provided

and we can adapt the stands at requirements to maximise the seating area for all people joining.

<u>Tanya</u>: Staff centre restaurant area offer a lot of kitchen equipment and we hope we can use the Coffee machine too

Latvia NR: The max. number of tables one nation can have is 6?

<u>Diana</u>: Yes, for the product stands, but we will see later end of June if it can be more, it depends on how many countries will participate at the Bazaar, so maybe 8 tables is also possible.

<u>Lithuania NR</u> is interested in where can they use the NCB stamps? Also, on goods packages?

<u>VP Catharina</u> responds yes, the stamp can be used on the product packs
